

Política Corporativa de Compra Sustentável de Grãos BRF / BRF's Grain Sustainable Purchasing Policy

Versão Inglês / English Version

1 OBJECTIVE

Based on BRF's fundamental commitments of Integrity, Quality, and Safety, this Corporate Policy ("Policy") establishes the guidelines of BRF S.A. ("BRF" or "Company") and its subsidiaries regarding commitments and principles to be applied in the business, with a focus on incorporating environmental, social, and sustainable practices into the management of BRF's production chain.

2 APPLICABILITY

This Policy applies to all BRF's Employees and Business Partners, as well as to any other public with which BRF trades grain, especially in areas of high social and environmental vulnerability, with risk of deforestation, in Brazil and abroad.

3 ROLES AND RESPONSIBILITIES

The Vice President of Reputation and Sustainability and the Vice President of Integrated Planning and Supply are responsible for proposing and updating this Policy regarding the public to which it applies, seeking alignment with the best practices in the market. As well as managing the compliance of its direct and indirect grain Business Partners with the guidelines described in this Policy.

The Sustainability, Animal Welfare, and Environment Board and the Commodities Board are responsible for clarifying any doubts related to this Policy, establishing the necessary procedures for its implementation, communicating, and training the target audience on the guidelines established in this Policy.

It is up to all BRF's Collaborators and grain Business Partners to comply with the guidelines established in this document.

4 GUIDELINES

BRF's commitment is to ensure a sustainable grain supply chain, whose origin comes from deforestation-free areas, as well as to guarantee the traceability of grains acquired in the

Amazon and *Cerrado* (Brazilian savanna) biomes, according to one of the public commitments disclosed by the Company.

This commitment is part of a set of BRF initiatives to develop a more sustainable grain supply chain, in line with BRF's vision of the future and the Vision 2030 strategic plan. The commitment also reinforces procurement procedures, considering compliance with the main socio-environmental criteria, in particular on deforestation in the Amazon and *Cerrado* biomes.

To do this, the grain Business Partners must:

- Comply with current and applicable environmental laws, as well as those described in BRF's Code of Conduct for Business Partners and BRF's Sustainability Policy.
- Respect the global commitments in the ESG (Environmental, Social, and Governance) aspects, connected to the Company's 2030 vision.
- Respect human rights, dignity, aspirations, culture, and livelihoods based on natural resources and avoid, minimize and/or compensate for any adverse impacts on local communities.
- Do not sell and/or produce grain from areas with restrictions for the use of Labor analogous to slavery and/or child labor.
- Avoid, minimize and/or compensate for any adverse impacts on local biodiversity arising from operations.
- Report to the Sustainability, Animal Welfare, and Environment Board and the Commodities Board any deviations and doubts about this Policy.
- Report any act that may represent a violation or potential violation of this Policy, or that is in disagreement with applicable national and foreign legislation, to the Transparency Channel, made available by BRF in the <u>compliance.brf.com</u> domain. Also, it is possible to make complaints by phone, website, or email.
- Additionally, regarding the origination of grains in Brazil:
 - Comply with the Brazilian Forest Code.
 - In the Amazon biome, consider "Zero Deforestation", that is, not to produce grains in areas that have been illegally deforested, with any suppression of vegetation or any other environmental irregularity, as well as not purchasing or selling products with such origin.
 - Do not produce grains in the *Cerrado* biome, in areas that have been illegally deforested or with any other environmental irregularity, as well as do not purchase or sell products with such origin.
 - Respect, in other Brazilian biomes, the environmental legislation in force.
 - Comply with current legislation in cases of overlapping property to Conservation Units (UC), Environmental Protection Areas (APA), Landless Workers Movement's Settlements, *Quilombolas* and Indigenous Peoples.
 - Do not sell and/or produce grains in areas that appear on the embargoed lists of the bodies: Brazilian Institute for the Environment and Renewable Natural Resources (IBAMA), Chico Mendes Institute for Biodiversity Conservation (ICMBio), and State Environment Secretariats (SEMA), when available.
 - Do not appear on the Dirty List of Slave Labor (Employers Register), of the Brazilian Ministry of Economy, as the list is issued and made available for consultation.

6 FINAL PROVISIONS

BRF reserves the right to assess any restrictions on its Business Partners and address, at any time, issues of non-compliance with BRF's Code of Conduct and Sustainability Policy, through reputational analysis and continuous monitoring. In case of non-compliance with any cases described in item 4 (Guidelines), BRF will submit to its Multidisciplinary Grain Sustainability Committee for evaluation. BRF can request clarification, supporting information, define mitigating measures, and eventually even suspend and/or cancel contracts with Business Partners that do not meet the guidelines described in this Policy and other normative documents related to the management of the Company's Business Partners.

Monitoring progress will be reported in the Integrated Report and/or other disclosure mechanisms of the Company, in a continuous effort to improve its Sustainability Policy and Code of Conduct for BRF's Business Partners.

This document is valid from the date of its publication and can be changed at any time and any discretion.

It will be up to the drafting areas to clarify any doubts, establish the necessary procedures for the implementation, verification, and dissemination of the guidelines mentioned in this document.
